The five separate, independently certified EPDs provide clarity and transparency about the life-cycle and environmental impact, a declaration unmatched by our competitors.

Phenol formaldehyde is a known carcinogen and even low levels are considered unacceptable by leading air quality certification organisations. This places ecoinsulation® glasswool insulation in a unique positon and makes it impossible for our competitors to currently match this level of certification.
